

## STAR FOR A DAY CONTEST RULES & REGULATIONS

- CONTEST PERIOD:** The Star for a Day Contest starts on June 7, 2011 and closes on September 30, 2011 at 12:00 PM Eastern Time. The Contest is presented by Brickman Concerts, Inc. and JMB Tours, LLC (the "Presenters.") The Presenters are and shall remain solely responsible for the delivery of the Prize to the winner.
- ELIGIBILITY:** This Contest is only open to residents of the United States of America who are residing in the United States of America and who are 16 years of age or older. If a minor is selected, the parent or legal guardian of the selected Entrant must sign an affidavit, in order for the minor to be declared the winner. The Prize will be issued in the parent or legal guardian's name if the Winner is a minor. Employees and their immediate families or sponsors of Brickman Concerts Inc. or JMB Tours, LLC or any of the companies that are supplying contest prizes are not eligible to enter or win.

Jim Brickman will serve as the Musical Director and have complete authority and responsibility for the performance and related repertoire.

All entries will need to be uploaded to the Entrant's personal YouTube page. When the Entrant is ready to submit his or her entry, the form at [www.jimbrickman.com/starforaday](http://www.jimbrickman.com/starforaday) needs to be filled out and the direct link to the YouTube video needs to be submitted. After the entry form is completed, please hit submit and confirmation will appear stating that your entry has been delivered.
- CONTEST DRAW(S):** One Winner will be selected from all entries submitted. The Presenters estimate at least five hundred entries to be submitted.
- PRIZE AWARDING:** The Winner will be notified by email within fifteen (15) days of the contest closing day. The Winner will be chosen only on verification by the Presenters that all contest requirements have been met by the Winner. The Winner will have ten (10) calendar days from notification to accept the prize by email, and will be instructed whom to contact at that time. The Presenters are not responsible for and shall not be liable for late, lost, misdirected or unsuccessful efforts to notify the Winner. If a selected Entrant cannot be contacted within the allotted time, the Presenters reserve the right to void that entry and select another eligible Entrant for that prize. In order to be declared an official Winner, the selected Entrant will be required to complete, sign and return to the Presenters a Declaration and Release Form within seven (7) days of receipt. If a selected Entrant fails to complete, sign and return the Declaration and Release Form

to the Presenters within seven (7) days, the Presenters reserve the right to void that entry and select another eligible entrant for that prize. By completing, signing and returning the Declaration and Release Form, the Entrant (i) confirms compliance with these Contest Rules and Regulations, (ii) gives permission to the Presenters, at their option, to publish or otherwise use the Winner's name, address, photograph, voice and comments without compensation, in any publicity carried out by the Presenters and (iii) assigns to the Presenters all of his or her right, title and interest (including all copyrights) in and to any and all work product conceptualized, prepared, developed, generated and submitted pursuant to this Contest. If more than one individual elects to collaborate on an entry, they are required to designate only the one person who will perform live on stage if selected as the Winner. Any communications regarding this contest will be directed to that designated person and the prize will only be awarded to that one person. The Presenters and all other individuals and entities related to this contest group as described in Section 10 are not liable for any disputes between or among any collaborators on any entry.
